Ohio landlords must return a tenant's security deposit and provide an accounting of any amounts withheld within 30 days of the tenant vacating the dwelling. The landlord must either return the security deposit to the tenant or transfer the tenant's security deposit to the new owner if he should sell the property.

Tenant must have first notified landlord in writing of landlord's failure to fulfill obligations defined in §§ 5321.04 or in the rental agreement, or if a governmental agency has found code violations that could affect health and safety, AND landlord has failed to remedy the conditions in a reasonable amount of time considering their severity and the time necessary to remedy, or within 30 days,
